

RULES OF THE SHOW

Saturday, May 4, 2019: Judgment of the 1st, 2nd, 3rd, 4th, 10th groups

Dogs judged on Saturdays will not be admitted to the exhibition grounds on Sunday except the winner of each group (B.O.G.)

Sunday, May 5, 2019: Judgment of the 5th, 6th, 7th, 8th, 9th groups

Dogs judged on Sundays are not allowed in the exhibition grounds on Saturdays

The entry of an uncommitted dog is strictly prohibited without the exceptionally written agreement of the Committee.

ARTICLE 1: Every exposed dog must be entered in the Book of origin or R.I. of a member country of the F.C.I. or of a non-affiliated country but whose original book is admitted by the F.C.I. and must be the property of the exhibitor.

The entry number and initials of the original book must be included in the commitment sheet.

DOGS AND PLACEMENT

ARTICLE 2: The entrance of the dogs will take place on Saturday 4 and Sunday 5 May from 7.30 am. Judgements will start at 9:00. Dogs should be installed close to their judging ring. The use of any electrical device is under the sole responsibility of the exhibitor. The Committee reserves the right to prohibit any installation and equipment or to limit its use at certain spots.

DOGS EXIT

ARTICLE 3: Dogs will be able to leave the exhibition definitively from 15:00 onwards. In this case, prizes and rewards will be lost (see Art. 12). However, between 12:00 and 2.30 pm, dogs will be able to go out against a bail voucher of 50 Euros per dog to be delivered at the Secretariat. This deposit will be returned on presentation of the dog before 2.30 pm.

PAYMENT OF COMMITMENTS

ARTICLE 4: In order to facilitate the organisation, the exhibitors are requested to pay their registration fees by bank transfer to the Société Canine de Monaco: 12 Avenue d'Ostende, Monte-Carlo, MC 98000 (Principality of Monaco) ó Bank details available on entry form. **Any unliquidated commitment will not be taken into account. Registration fees must be paid at the same time as the commitment sheet is sent.**

COMITMENTS

ARTICLE 5: A dog's commitment in more than one individual class is prohibited. Each dog must be listed in "Minor Puppy Class", "Puppy Class", "Junior Class", "Intermediate Class", "Open Class", "Work Class", "Champion class", "Veteran class", "Class out of competition". Pair/Couple, Breeding are not considered as individual classes.

The commitment sheets must be written in the machine or in print.

The rates are as follows:

-65 Euros per dog engaged in the individual class young, intermediate, open, work, Champion.

-35 Euros for the individual class Minor puppy, puppy, veteran.

-15 Euros for the non-competitive class (valid only if at least one dog is registered in another class).

-25 Euros for the pair/couple class. Free for the Breeding class. Dogs composing the pair/Couple and Breeding class must first be engaged in an individual class. Any dog whose class has not been specified on the commitment sheet will be registered in open or young class depending on its age.

N.B. The closing of the registrations is irrevocably fixed on **30 March 2019**. Any incomplete, illegible or unreadable commitment to the copy of the PEDIGREE will be refused as well as any commitments reached after the closing date or not accompanied by the amount of the registration fee. Registration fees must be paid at the same time as the commitment sheet is sent. These rights will remain vested in the Monaco Kennel Club even if the exhibitor cannot present his dog.

ARTICLE 6: Any request for modification or registration in other classes on the day of the exhibition will be refused, except for the Breeding class.

ARTICLE 7: Ear Cut: Monegasque legislation has banned otectomieö, dogs with cut ears are no longer allowed, however, dogs with cut-tails are allowed.

REFUSAL OF COMMITMENTS OR EXPULSION OF DOGS

ARTICLE 8: Commitments: The Committee reserves the right to refuse, without indicating the reason, the commitment which does not think it deserve and refund the amount even after accepting it.

Dogs (at their entrance or during exposure): will be expelled from the ring and the exhibition, without reimbursement of commitments, dogs whose grooming is not in conformity as well as those who have undergone any mutilation not provided for in the standard.

Any dog refused by the veterinary services.

Any uncommitted dog. Any villain or dangerous dog.

JUDGES

ARTICLE 9 : Judgments are made under the sole and personal responsibility of the judge. They are without appeal and definitive. Any dog absent at the time of judgment will not be able to be examined afterwards. Access to the ring is strictly reserved to the judge, Ring Secretary, Ring commissioner, member of the organising committee, possibly interpreter and exhibitors at the time of judgement. Access for any other person is strictly forbidden. For the judgements of the Best of Breed and the Best of Group in the Ring of honor, after three successive calls, the dogs not presented will be considered absent.

ARTICLE 10 : The Committee reserves the right to modify the list of judges even after it has been published.

C.A.C.I.B. ó C.A.C.M. ó CHAMPION TITLE

ARTICLE 11 : The judges can propose for the International Beauty Championship (C.A.C.I.B.) and for the Monaco Beauty Championship (C.A.C.M.) the most beautiful male and the most beautiful female of each breed provided they are of exceptional merit and be registered in a class giving them the right to this award.

C.A.C.I.B. :

May only be awarded to first class dogs with the "excellent" qualification entered in the Intermediate ó Open ó Work or Champion Class.

Can only be assigned to dogs with a minimum age of 15 months on the opening day of the exhibition.

N.B.: C.A.C.I.B. are only approved by the F.C.I. (Fédération Cynologique Internationale)

C.A.C.M. :

Can only be attributed to dogs classified as first excellent registered in the class "intermediate ó Open or work"
(only 1 C. A. C.M. by sex between the above 3 classes)

IMPORTANT : Champion Class DO NOT ALLOW C.A.C.M.

R.C.A.C.I.B. and R.C.A.C.M. :

Can be awarded to dogs ranked second excellent and of equivalent quality to those having obtained the C.A.C.I.B. or the C.A.C.M.

The R.C.A.C.I.B. does not turn into C.A.C.I.B. unless the dog who has obtained the C.A.C.I.B. is already an International Champion
N.B.: Les R.C.A.C.I.B. are only approved by the F.C.I. (Fédération Cynologique Internationale)

The R.C.A.C.M. does not turn into C.A.C.M. unless the dog having obtained the C.A.C.M. is already Champion of Monaco.

BEST OF BREED :

Dog (male and female) proposed for the C.A.C.I.B. compete for the Best of Breed title, as well as the best young male and the best young female who received the first Excellent qualifying in the young class and the best veteran who received the Excellent qualifying.

MONACO CHAMPION TITLE :

Will be awarded to any dog having obtained two C.A.C.M. homologated under two different judges and in two different years (without time limit). Any dog already bearing the title of champion of beauty of MONACO must be registered in the Champion class.

N.B. : The registration of the Monaco Championship is done in June (after the FCI palmarès) and not on the spot. You will have to send us the copy of the 2 C.A.C.M. and the trial slips by post or by mail. The diploma will be sent to the postal address of the catalogue.

YOUNG CHAMPION OF MONACO TITLE :

Will be awarded to any dog, male and female having obtained the first EXCELLENT qualifying in the young class.

N.B. : The registration of the Monaco Championship is done in June (after the FCI palmarès) and not on the spot. You will have to send us the copy of the 1st EXCELLENT and the trial slips by post or by mail. The diploma will be sent to the postal address of the catalogue.

CHAMPION VETERAN OF MONACO TITLE :

Will be awarded to any dog, male and female having obtained the first EXCELLENT qualifying in the veteran class.

N.B. : The registration of the Monaco Championship is done in June (after the FCI palmarès) and not on the spot. You will have to send us the copy of the 1st VETERAN and the trial slips by post or by mail. The diploma will be sent to the postal address of the catalogue.

EXHIBITORS

The exhibitor must not leave the ring without his cards and his briefs of judgement. In the event that the judge or the Ring secretary fails to give them in the ring, he will have to claim them before leaving the ring. It is his responsibility to check that he has all his cards and that they correspond well to the briefs of judgement.

PRIZES AND REWARDS

ARTICLE 12 : Prizes to all the CACIB and RCACIB, to all the CACM and RCACM and to all the excellent classified (1-2-3-4). These prizes are not cumulative and will be distributed at 3.30 pm.
Prizes not withdrawn on the day of the exhibition will not be sent to the exhibitor.

CLAIMS - PENALTIES

ARTICLE 13 : Any claim whatever the reason except the one concerning the judgments as these are without appeal, must be made in writing and accompanied by a deposit of 80 Euros remaining acquired to the Monaco Kennel Club if the claim is recognized unsubstantiated before 3:00pm on the day of the closure.

ARTICLE 14 : The Committee reserves the right to crack down as it deems useful to anyone who is considered likely to interfere with the perfect holding of the exhibition. The extension of the penalty against an exhibitor may be requested from the F.C.I. to be applied in all events organized under its patronage.

RESPONSABILITIES

ARTICLE 15 : The company declines all responsibility in case of escape, loss, theft (dogs, objects, money, etc...), sickness, death, animal bites or several accidents.

ARTICLE 16 : It is forbidden to expose dangerous dogs. Exhibitors are totally responsible for the bites or damage that could be done by their dogs.

ORDER MEASURES

ARTICLE 17 : In case of inability to open the exhibition for major reasons and/or beyond the control of the organizers, the rights of commitment will not be reimbursed, the costs of exposure having been incurred. The Monaco Kennel Club reserves the right to make any changes it deems necessary in the organisation.

ARTICLE 18 : By the fact of sending the commitment of their dogs, all the exhibitors fully accept the articles of this Regulation.

ARTICLE 19 : In the event of a disagreement concerning this regulation, the Monegasque court will solely be competent.

ARTICLE 20 : Any sale of dogs and display referring to it within the enclosure of the exhibition are strictly forbidden.

ARTICLE 21 : Any grooming and preparation of a dog inside a ring is strictly forbidden. The use of electrical equipment is prohibited unless authorized by the Committee. On the other hand, it is also forbidden to leave the dog attached on the grooming table longer than it requires its preparation.

ARTICLE 22 : The organization recommends to owners of dogs of breeds Rottweiler, Tosa, American Staffordshire Terrier to make any provisions relating to the current article of law: held on leash and muzzle by a major person outside the rings and Cages.

DISCIPLINE

ARTICLE 23 : Any exhibitor who does not conform to this regulation, with an aggressive or disrespectful attitude during the exhibition, will be sanctioned by the disciplinary committee. After examination and according to the severity, the offending exhibitor may be banned from exhibition in Monaco for one or more years, but also the non-homologation of the Monegasque championship.

SANCTIONS

ARTICLE 24 : May be temporarily or permanently excluded from the exhibition of the Monaco Kennel Club with possible extension to the events organised by its affiliated Associations:

- Exhibitors who will be guilty of facts against honor.
- those who made a false statement.
- those who have subjected their dog to any operation likely to deceive on the quality of it.
- those who, by their language, their writings, their actions, would harm the success of the exhibition or undermine the prestige of the judges and the organising society.
- Those who have secretly introduced an uncommitted dog or replaced a dog hired by another.
- Those who have left the exhibition before the scheduled time.
- Any exhibitor belonging to a club or a canine company not affiliated with the S.C.M. or an organization not recognized by the F.C.I.
- Exhibitors who have not ensured the safety and comfort of their dog or who have mistreated him in any way.

SANITARY REGULATIONS

ARTICLE 25 : The valid rabies vaccination certificate will be required for the Monaco exhibition (for dogs coming from a country where it is compulsory).

In order to make health control more effective and in the interests of all exhibitors, it is recalled to carry certificates of vaccination against the disease of Carré, Rubarth and Parvovirus.

The health book or passport with the needed vaccines is to be presented at the exhibition.

Any dog appearing ill, suffering from skin disease, blind or crippled, Cryptorchid, monorchide or suffering from malformations, any dangerous dog as well as the dogs in a lactating state, visibly full, in heat or accompanied by their babies will be refused by the veterinary Services without reimbursement of commitments.

RING OF HONOR

ARTICLE 26 :

Minor-puppy Class : Only dogs who got the qualifying for BEST MINOR-PUPPY returns to the Ring of honor to compete and get the title of "Best minor-puppy of the show".

Puppy Class: Only dogs who got the qualifying for BEST PUPPY gets back in the Ring of honor to compete and get the title of "Best Puppy of the show".

Young Class: Only dogs with the BEST YOUNG qualifying enters the Ring of honor to compete and get the title of "Best Young person in the show."

Veteran Class: Only dogs with the qualifying BEST VETERAN returns to the Ring of honor to compete and obtain the title of "Best veteran of the show".

Dogs whose race is not homologated by the F.C.I. do not participate in the Ring of honor.

Dogs not participating in the Ring of honor for the B.I.S. will not have their rewards approved.

Dogs who have obtained the title of Best Group on the 1st day must present themselves for the final judgement of the B.I.S. on the 2nd day of the exhibition under penalty of punishment.

CONFIRMATIONS (only for L.O.F. dogs registered)

The confirmations will be made by a French judge at the entrance of the exhibition on Saturday 4 and Sunday 5 May 2019 from 14:00 to 15:00 according to the races judged of the day.

IMPORTANT NOTICE

Exhibitors, accept with sportsmanship the judge's decision! He is responsible for his judgment which remains without appeal.
